

PARKER BOILER PRODUCTS LIMITED WARRANTY

Parker Boiler Co. warrants to the original user that those products supplied by it and used in the service and manner for which they are intended shall be free from original defects in materials and workmanship subject to conditions herein stipulated.

The boiler pressure vessel is covered by a 25 Year Warranty against damage caused by thermal shock during all normal operating conditions. Main Boiler Components consisting of drums, tubes, headers, cabinets and cast iron gas burners are covered by a 5 Year Pro-Rata Warranty (Coverage decreases 20% per year after the first year). Tanks, Heat Exchangers, Softeners and other components are covered by a 1 Year Warranty. Pumps, Valves, Trim Burner and Controls manufactured by others are covered by a 1 Year Warranty provided that the original manufacturer will replace the item under their Warranty. Normal Maintenance Items such as gaskets, water gauge glasses, rubbers, pump seals, pump tubes, and accessories, etc. are covered by a 90 Day Warranty. Normal tightening of water gauge glass nuts, gaskets and pipe fittings is not considered Warranty. The effective date of the Warranty shall be the time the equipment is placed in operation but not to exceed 3 months after delivery unless Manufacturer is notified in writing and agrees to a later date. The standard Warranty excludes field labor and freight charges.

This Warranty covers only original defects and does not cover replacement of parts due to normal wear or resulting from scale, corrosion, rust, electrolysis or deterioration of parts due to a bad water condition or improper care of equipment. This Warranty will not apply to any products subject to misuse, neglect, or damage or to any product repaired or altered outside of the Manufacturer's factory. The Warranty will not apply to any product not properly installed and operated to Manufacturer's recommendations in compliance with all applicable Codes. A proper start up by a competent boiler technician shall be performed for warranty to be in effect. Start up sheets shall be available for Parker Boiler Co.

The responsibility of the Manufacturer under this Warranty is limited to repairing or replacing at its factory or other destination at Manufacturer's option, any defective product returned transportation charges prepaid. The Manufacturer shall be sole judge in determining if the product returned is defective. The Manufacturer is not responsible for any field labor charges incurred in the removal, disassembly or reinstallation of any kind in connection with the use, sale or repair of any product. The Company is not liable for any loss, damage, cost of repair or consequential damages of any kind in connection with the use, sale or repair of any products or parts.

This Warranty is in lieu of all other Warranties, expressed or implied and any or all other obligations on its part, contractual or otherwise. No Employee, Agent, Distributor or Dealer shall have the right to modify or change this Warranty without written authorization signed by an officer of Parker Boiler Co.
